Thank you for contacting us to handle the clearance of your automobile.

At least 48 hours before the vehicle is loaded on the vessel overseas, an Importer Security Filing (ISF) must be done. We can handle this filing on your behalf. This information is normally supplied by the Shipper overseas. Please see the attached information. We will need the completed and signed Customs Power of Attorney to complete the filing.

Our fee for clearance, etc. is as follows:

Customs clearance: \$250.00 per shipment

ISF Filing: \$75.00 per shipment

<u>Customs Duty</u>: 2.5% of the value (If the vehicle's intended purpose is not for transporting persons, the 2.5% duty rate <u>would not apply</u>. If this applies, please contact us for further information) (If the vehicle is a returning U.S. titled vehicle not purchased overseas, it would not be subject to duty.

You must advise if your vehicle is for personal use or re-sale.

There may be charges due to the Shipping Co. You would be responsible for these charges. The pier will provide five free days in which to pick up your auto. If the auto is not cleared and picked up within this time frame, storage charges will incur. If U.S. Customs and Border Protection should decide to examine the vehicle, this could take some time and storage charges may incur.

We can obtain rates to move your vehicle with a Car Carrier from the Port to its final destination.

The following documents/information are required for clearance:

- > Completed and signed Customs Power of Attorney (attached)
- ➤ Completed and signed EPA & DOT forms (attached)
- ➤ Legible copy of your Title and Registration
- Legible copy of your Passport and Visa or Driver's License
- ➤ Bill of Sale
- ➤ If your vehicle conforms to U.S. EPA & DOT standards and is not over 25 years old, you must provide a clear picture of the engine label that provides the Test Group Name or the

Engine Family Name. It is a letter/number combination and includes 12 characters (including periods). This should appear under the hood of the vehicle or on top of the engine. If this is not provided, your vehicle could be denied entry. Please also include a picture of the vehicle.

- Copy of the Ocean Bill of Lading once the vehicle has shipped
- > Type of fuel the vehicle uses
- > Cylinder capacity of the vehicle

We do require payment prior to pick up. We accept cash, credit cards (there is a 3% processing fee with a minimum of \$10.00. If American Express is used, the processing fee is 4% with a \$10.00 minimum), or a cash deposit directly into our account.

If you decide to pick up your vehicle at the port, you may have to utilize a Certified Escort Service to accompany you into the Marine Terminal. Each port is different. Upon release of your vehicle, we will advise whether or not an Escort Service is required. If an Escort is required, you would be responsible to contact the Escort Service and pay their fee direct.

Please do not make any pick up arrangements until we advise the vehicle is fully released and available for pick up.
